## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

Because public distribution of tests performed and the related results over information technology could increase the risk to the District's IT security, distribution of that information has been limited to management and the governing body of the District and is kept confidential under RCW 42.56.420.

## About the audit

This report contains the results of our independent accountability audit of Valley School District No. 70 from September 1, 2015 through August 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended August 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Student enrollment reporting (basic education)
- Selected IT security policies, procedures, practices, and controls protecting financial systems, IT systems, and data
- Self-insurance evaluation
- State grant healthy kids grant
- Procurement –purchase of a school bus

## **INFORMATION ABOUT THE DISTRICT**

Valley School District No. 70 provides educational services to approximately 196 kindergarten through eighth grade students in its traditional classrooms. The District hosts a cooperative onsite high school, Paideia High School, comprised of five non-high school districts serving an average of 59 students. Columbia Virtual Academy is the District's online and parent partnership program serving approximately 445 choice students from across Washington State. Additionally, the District operates the Valley Early Learning Center, providing preschool instruction to approximately 43 students. The District also operates the VL Transport Center Cooperative, which is a state-of-the-art transportation facility providing mechanical and fuel services for 12 school districts.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's day-to-day operations as well as its 113 employees. For the years under audit, the District operated on annual General Fund budgets of approximately \$9.7 and \$9.9 million for 2015-2016 and 2016-2017, respectively.
