New GPS Technology Onboard

Have you ever been running late in the morning and wonder if the kids have missed the bus? Need to pick up the kids after a field trip and want to know exactly when the bus will arrive?

Valley School District's new school bus tracking technology and fleet management system, UbicaBus, is now onboard VL Transport Center buses to assist families with information about their student's bus route, stops and expected time of arrival.

Steve Templeton, Transportation Supervisor at VL Transport Center, is anticipating improvements in route management and efficiency, and staff and parent satisfaction with use of the UbicaBus technology.

Each of the seven Valley and four Loon Lake route buses have been equipped with a UbicaBus Location Messaging Unit (LMS), which is a GPS tracking and diagnostic device that transmits each bus's current location and updates every five seconds.

Once VLTC staff become well-versed with the UbicaBus operating system this fall, families will be notified to access the user-friendly Parent App on their Android and iOS devices to view the route map and track their bus's travel progress in real-time. Parent accounts may be customized to receive arrival and delay alerts, and school notifications about inclement weather delays, cancellations or emergencies that may be affecting regular service.

Mr. Templeton is using the UbicaBus route planning tools to tailor each route for optimal travel time and distances, stop locations and order, helping to minimize student wait and travel times.

Routes will be easier to alter in response to periodic new student pick-ups, road construction or bad weather. Historical data and information will allow Steve to review and compare new routes with previous routes and then adapt them based on ridership rates and fluctuations in student enrollment.

The UbicaBus platform also supports data management of route, driver, student, and parent information, allowing easy updates throughout the year.

Fleet management reports provide current and historical data on route performance and deviations, bus speed and idle time, delays and mileage. The on-board diagnostic system can analyze the vehicle's overall run time, miles traveled and months of service to detect potential issues and track repairs during its usable lifespan. VL staff can remotely monitor a bus's mechanical performance and set alerts and reminders for maintenance tasks such as oil and fluid refills and changes, and tire rotations.

Oh, the wonders of technology! Valley School District, VL Transport Center and its partners are working diligently to improve transportation services for our area student and families.

All aboard UbicaBus!

Paideia High School has reduced the length of the regular school day by 10 minutes. Classes begin at 8:35 a.m. and students are released at 3:15 p.m. daily.

Child Find

Valley School District offers many academic programs and services for all children residing within district boundaries, including developmental screenings and comprehensive assessments for those suspected of having a disability which could adversely affect their suc-

cess in school. Early identification and intervention helps children become more independent and achieve at higher levels

Schools provide educational support programs such as Title I, Learning Assistance Program (LAP), special education and speech, physical and occupational therapy. Families experiencing homelessness or with lowincome, foster children, and/or children with developmental delay or disability, including speech difficulties, may qualify for preschool services (ages 3-5) at no cost. If you have concerns about your child's development, contact the school to arrange a free screening for speech, hearing, language, motor, social and learning skills. Individuals from birth to twenty-one (21) years of age may be screened and eligible for district services. For more information or to arrange an appointment, please contact the Special Services Director at (509) 937-2859, or the district administrative office at (509) 937-2791.

Healthcare Reminder

Parents: Before the first day of school, be sure to have your child's immunization form ready and, if applicable, prepare the physician's orders form and medication administration form plus any medications that will be brought to school.

The McKinney-Vento Homeless Education Act

Assisting Children in Need

If your family lost permanent housing and now live in a temporary shelter, inadequate housing, and/or lack a fixed, regular nighttime residence, your children might be able to receive help through a federal law called the McKinney-Vento Homeless Education Act.

Under this Act, children and unaccompanied youth in homeless situations have the right to receive a free, appropriate education and immediate enrollment in the school of choice (even if they are missing a permanent address, required records or documents); to receive free meals at school and transportation assistance; to access the same academic program and school services for which he/she qualifies as available to non-homeless students.

Management of Student Information

Student records contain information which is collected and maintained by the school on a routine basis for educational or operational purposes. Student records are considered confidential and, generally, personally identifiable information may not be disclosed to an individual or agency ("third party") without written parent/guardian consent, unless there exists a legitimate educational interest or other exception as allowed by the Family Educational Rights and Privacy Act (FERPA). One such exception is the transfer of student records and information to an official of another school or institution where the student has enrolled or intends to enroll.

Accessibility to student records is guided by Valley School District policy in accordance with state and federal laws. Parents, guardians and adult students have the right to: inspect and review their child's record, and seek to amend information if they believe the record is inaccurate or misleading; consent to disclosures of personally identifiable information, except to the extent that FERPA authorizes

disclosure without consent; and to file a complaint with the U.S. Dept. of Education.

Student Directory Information is the portion of the education record that generally would not be considered private information and which may be included in district or community publications such as newsletters, theatrical playbills, yearbooks,honor roll or award lists and sports programs.

Directory information may be released publically without parental consent, though a parent/guardian has the option of restricting the release of such information without prior consent by providing written notice to the district administrative office within ten (10) business days of enrollment or first day of school.

Additionally, secondary schools must provide military recruiters and postsecondary educational institutions, upon request, with student names, addresses and telephone numbers, unless a parent/guardian "opts out" in writing of the release of this information.

- Date and place of birth
- Dates of attendance
- · Grade level
- Major field of study
- Participation in officially recognized activities and sports
- Weight and height of members of athletic teams
- Degrees, honors, and awards received
