Roll call was taken with a quorum present.

## **DISCUSSION ITEMS**

ATSDR Health Consultation Exposure Investigation:

Debra Gable and Dr. Aaron Young from the Agency for Toxic Substance and Disease Registry (ATSDR) discussed the recently released Ambient Airborne Exposures to Particulate Matter and Silica Dust in Valley School, Valley, WA report. Debra Gable gave a brief history of the Exposure Investigation that was completed in the summer of 2016. Board members, Department of Ecology, Department of Health and Lane Mountain all received a copy of the report. The electronic version will be posted

in about a week on the CDC website. Debra and Dr. Young then reviewed the four conclusions and addressed board questions. Discussion followed about the findings of silica and the particulate size and concentration. One finding states that some people who breathe PM<sub>10</sub> on the Valley School campus, specifically sensitive populations (children, elderly and adults with conditions such as asthma), could experience short-term health problems. A second finding states "breathing PM4 crystalline silica on the campus of Valley School and in the surrounding area presents a potential long-term public health hazard to students, staff and residents". Debra said this report is the first step of a process in determining what to do next. She hopes to see all the agencies (ATSDR, Dept. of Ecology, Dept. of Health) and Lane Mountain and Valley School District work together to find a solution. Dr. Young said the school should not have to monitor the concentration of particulate matter and that ATSDR wants to work together with all the parties.

Dave Knight and Andy Kruze from the Department of Ecology presented and reviewed a handout to the board containing background information and a Q&A. They explained that Lane Mountain filed a Notice of Construction for bag house installations to replace the current scrubbers. That project is anticipated to be completed this fall. As part of this project, Lane Mountain must have a fugitive dust control plan and will be subject to regular inspections. They agreed that all agencies must work together.
